ITEMS ACCEPTED:

- Home and outdoor furniture (e.g. sofas, mattresses, box springs, chairs)
- Rugs and carpets
- Appliances (e.g. washers, dryers, ranges, water heaters)
- Up to 30-gallons of rock, dirt, asphalt or concrete per household
- Up to 30-gallons of construction or demolition debris per household
- Bicycles and exercise equipment
- Scrap metal under 40 pounds and less than 2 feet in length
- Wood waste - unpainted and untreated
- Tree trimmings - less than 6 inches in diameter and less than 6 feet in length



LIMITED HOUSEHOLD HAZARDOUS WASTE (HHW) ACCEPTED: (PLEASE LOAD HHW SEPARATELY)

- Fluorescent bulbs (compact, circular and u-shape) and tubes
- Household batteries (A, AA, AAA, C & D)
- Computers, printers, scanners, fax machines
- Computer components (mouse, keyboard, wires)
- TV's (CRT's, flat-screen, LCD)
- Cell phones, clocks, DVD/CD players, game consoles
- For all other HHW items, please call (408) 299-7300



ITEMS NOT ACCEPTED:

- Appliances containing Chlorofluorocarbons (CFCs) (e.g. air conditioners, refrigerators)
- Fuel cans or engine parts containing oil, grease or gasoline (eg. hedge trimmers)
- Large amounts of rock, dirt, asphalt or concrete
- Oil or gas space heaters
- Large pieces of glass
- Hover boards
- Tires
