Dumpster Rental for a 3-day duration. For instance, if your dumpster is delivered on a Monday, the removal will be scheduled for Thursday or later.

Please be aware that removal times are scheduled randomly between 6 am and 6 pm. The dumpster will be automatically picked up unless you request an extension at least 24 hours in advance. To request an extension, please call us at 916-388-0199.

Our driver will contact you via phone call and/or text message before the delivery or removal process. In some cases, removal may occur after the initially scheduled removal date, but rest assured, you will not incur additional charges for extra days unless you specifically request them.

It's crucial to understand that our pricing is determined by the weight of the materials being disposed of, not the size or volume of the dumpster. The initial weight covered by the \$199 fee is ½ ton (1,000 pounds). If the total weight of your disposal exceeds this initial weight, additional disposal charges will apply at a rate of \$90 per ton, in addition to local franchise fees.

What's NOT Included:

All charges are subject to local franchise fees. For the City & County of Sacramento, Citrus Heights, and Elk Grove, franchise fees are 10%, while West Sacramento charges 12%, and Rancho Cordova imposes an 8% fee.

Additional charges apply for specific items such as tires and mattresses. Please refer to our additional charges section for specific details.

Please note that we do not provide recycling reporting as part of our services for the \$199.00.

Additional Charges and Limitations

Box rental is for **3** days. For example: Deliver on Monday, Removal would be scheduled for Wednesday. If delivery is on Friday, then removal would be on Monday. Removal times are random and between the hours of 6 am and 6pm, removal times are not guaranteed. Removal may occur after scheduled removal date; the customer will not be charged extra days if this occurs. **BOX WILL BE PICKED UP AUTOMATICALLY UNLESS EXTRA TIME HAS BEEN REQUESTED 24 HOURS IN ADVANCE. ALL REQUESTS MUST BE MADE VIA CALLING 916-388-0199. The rental of the dumpster is \$199 plus franchise fee (City & County of Sacramento, Citrus Heights, Elk Grove is 10%, West Sacramento 12%, Rancho Cordova 8%) All materials after the initial 1000 pounds disposed of in the dumpster will be charged at \$90 per ton pro rata, plus franchise fee. All overages are charged to the credit card on file and will be charged immediately without notice. Customer will receive final invoice via the email address we have on file.**

We reserve the right to charge any addition charges that may be imposed by disposal facility for any materials not listed on our terms & conditions.

We reserve the right to charge any additional fees/charges charged by disposal facility for items/materials not listed on our terms & conditions or due to rate increases at the facility. All charges are subject to applicable franchise fees.

Effective 8-8-2023

Extra Days: All extra days must be requested 24 hours before scheduled removal / pickup. If the driver has been dispatched for removal of the dumpster, a dry run fee will be imposed.

Delivery/Removal / Emergency Removal: We give a 3-hour window for deliveries; this is only an estimated time for delivery and not guaranteed. The driver will call and or text when they begin service. Removal is automatically scheduled at time of order unless earlier removal is requested. If removal time is not listed within this contract (customer to call) it is the customers responsibility to call in for removal to avoid inactivity fees. Early removal times must be requested at time of order and or 48 hours in advance. We do not guarantee removal dates unless otherwise agreed to upon within this contract. Removal may take place on or after the date listed within this contract. We will not be held responsible for any claims due to late removal or delivery of the dumpster for any reason. In the event a dumpster must be removed due to an emergency or urgent request prior to the scheduled removal date we reserve the right to impose a \$150.00 (plus any applicable franchise fees) emergency removal fee. We do not guarantee emergency removal service would be available at any time. If same day service is requested that includes the delivery and removal in the same day, the removal time is limited to driver availability & no guarantee or promise is made as to the exact removal time of the dumpster. Time can be as early as 12pm or as late as 5pm depending on the driver's schedule. Late removal will be honored only when possible.

Swaps/Switch/Dump & Return/Additional Rentals: If the customer/renting party needs another dumpster of the same size and same material types, this is called a swap/switch/dump & return. The price is the same charge as the first dumpster that was delivered. The previous dumpster is removed and replaced with an empty dumpster. This service is immediately charged for when requested. The previous dumpster is then removed and taken to the disposal/recycling facility. If there are overages for that dumpster they are billed accordingly.

Street Placement: If the service address in the city limits of the City of Sacramento we can place the dumpster on the street in most cases. We must obtain an encroachment permit from the city prior to the dumpster being delivered, if all the city's requirements are met a permit will be issued. The length of the permit can vary, and placement is subject to the terms of the encroachment permit. Other jurisdictions such as the City of Roseville do not allow street placement and the dumpster must be placed on the property. The City of Lincoln, West Sacramento, City of Elk Grove will allow street placement with an encroachment permit only, it is the renting parties responsibility to obtain this permit prior to dumpster placement. A valid copy of encroachment permit must be received prior to delivery. The dumpster cannot touch the sidewalk or block a bike lane. No refunds or discounts will be issued due to shorter rental period due street placement requirements. Dumpsters placed on the street tend to have more illegal dumping occur and renting party is responsible for all materials placed into the dumpster. Customer/Renting party will be responsible for any damages that occur to the dumpster while placed on the street, including but not limited to, vehicle accidents, injuries, acts of God, hit, and run, and or any damages not reported upon delivery of the dumpster.

Minimum clearances required for delivery: **\$199 Dumpster is a 10 cubic yard dumpster** and is 16 feet long without the door open. There is one single door that is 8 feet long and swing to the back of the dumpster. Minimum length to open the dumpster is 25 feet or more. Dumpster is 3 feet tall. The dumpster cannot touch the sidewalk. Street placement dumpsters are not allowed via online orders. If street placement is required, a 3-day max rental may be imposed due to local restrictions. No refunds or discounts will be issued due to shorter rental period. A safe overhead clearance is also required for safe delivery and removal. A minimum width of 12-14 feet is required for the truck to safely deliver or remove the dumpster. If there are low lying trees, or utility lines the driver may not be able to provide service. A dry run fee may be imposed for this reason. The driver has full discretion for safe placement, if the driver does not feel safe making placement, they reserve the right not to place dumpster. A dry run fee may be imposed for this reason. The sizes and lengths listed are estimates only, and may vary due to dumpster style, manufacture.

Cancellation / Refund Policy: A minimum cancellation charge of \$150 (plus any applicable franchise fees) will be imposed for cancellations made on the same day, which includes cancellations after 4 pm on the preceding business day. If our truck has initiated the delivery or removal process, a dry run fee may also be assessed. If a cancellation request is submitted after the dumpster has been delivered, you will incur a dry fee for the delivery and an additional dry run fee for the removal process. The remaining balance of the rental fee will then be refunded to you.

It's important to note that if any materials have already been placed into the dumpster, the rental cannot be canceled, and full rental charges will be applied. We will make every effort to promptly remove the dumpster, but you are responsible for any materials deposited within the dumpster during this period. Should you choose to cancel the rental 24 hours before the scheduled delivery date, a full refund will be processed to the original payment method exclusively. The refund process typically takes 7-10 business days. Please be aware that refunds are only possible to the original payment method. In cases where the original payment method is not available for processing the refund, a check will

be issued within 21 days of the refund request.

Overloading / Use of Dumpster: All contents placed inside the dumpster must not extend beyond the rim of the container. In cases where the contents exceed the rim and our driver cannot safely cover the dumpster with a tarp, a dry run charge will be applied. You will be required to ensure that all contents are below the rim and that the doors are securely closed before the dumpster can be removed.

If our driver is unable to safely lift and remove the dumpster due to its weight surpassing safe limits, you will be held responsible for unloading the excess materials until the dumpster reaches a safe weight.

Dumpsters that exceed a weight of 10 tons may be subject to a minimum hard to handle fee of \$150, excluding any potential damages. The renting party assumes full responsibility for any Department of Transportation (DOT) violations, associated fees, fines, infractions, and damages arising from overloading the dumpster beyond its weight limit.

Should the situation require an additional dumpster to offload materials, you will bear the cost of the extra dumpster, as well as any expenses related to cleaning and transferring materials. This could also involve additional rental days for the previous dumpster.

In cases where the actual contents of the dumpster differ from what was initially rented, additional charges may apply. You will receive detailed invoices via email, including an invoice for the initial dumpster delivery, separate invoices for each switch or change, and an invoice listing any supplementary charges upon the final removal of the dumpster.

Payments / Charges: All dumpster charges are applied at the time of placing the order. Overages are automatically charged to the credit card on file upon pick-up. By signing this contract, the renting party authorizes these charges without further notice. The price displayed includes one delivery, one removal, the specified rental period, and the allotted disposal tonnage. Additional swaps, switches, empty-and-return services are considered new rentals and are charged upfront at the time of the request.

For all excess fees, payment must be made in advance before the dumpster is scheduled for removal. In cases where payment is made via credit card and the card is declined for any reason, we will contact the designated contact via phone, email, providing a breakdown of the overages.

If payment is not received within 72 hours of the initial request, we retain the right to impose a late payment fee of \$20 per day. If payment remains outstanding beyond 15 days, the account may be forwarded to collections.

Customers are required to make upfront payments for the services provided by the company. Any additional charges must be settled before the dumpster is removed. We reserve the right to adjust our rental fees at any time, with prior notice to our customers.

TERMS: The terms of this agreement are effective from the time of delivery to the time of pickup. If the customer wishes to extend the term of this agreement, an additional charge(s) must be paid in advance. Credit cards on file will be immediately charged for the amounts outlined in our terms & conditions. Customers acknowledge that any late charges imposed by the Company are not to be considered as interest on debt or finance charges but rather as reasonable compensation for the anticipated loss and cost to the Company due to late payment.

If payment is not made when due, the Company retains the right to suspend services until the past due balance is settled in full. Moreover, if services are suspended for a period exceeding fifteen (15) days, the Company reserves the right to immediately terminate this agreement for default. In such cases, the Company may recover any equipment and all amounts owed, including liquidated damages.

The Company holds the right to refuse the acceptance of loads for disposal due to fraud, suspicion of defrauding the company (including the use of prepaid credit cards or cancellation of credit cards before the end of service), placement of hazardous waste into the dumpster, or unpaid overages. In the event of refusal, the Company will notify the customer and may leave disposed materials at the location where the dumpster was placed. The Company will not be held responsible for damages arising from materials being left.

This contract remains valid for the current service and all future services (including dumpsters rented for other materials and sizes) at this address. It supersedes all previous agreements for this address.

MATERIALS: The customer or renting party is prohibited from placing certain materials in the dumpster. These materials include food waste (unless otherwise stated), hazardous waste, treated wood waste, toxic substances, or radioactive materials, as defined by applicable federal, state, or local laws and regulations. If any of these prohibited materials are found in the dumpster, the customer is responsible for their removal and disposal. Furthermore, the customer agrees to hold the company free from any claims or damages arising from these prohibited items.

The term "Waste Materials" excludes the deposit or collection of materials classified as radioactive, volatile, corrosive, flammable, explosive, biomedical, infectious, bio-hazardous, regulated medical, or hazardous waste, as defined, characterized, or listed under applicable federal, state, or local laws and regulations. Additionally, any materials containing information protected by federal, state, or local privacy and security laws or regulations are prohibited. Any other items or materials prohibited by federal, state, or local laws or regulations, or those that could potentially harm the operation or useful life of the facility(ies) receiving Customer's Waste Materials, are also not allowed. Similarly, any "Special Waste" not approved in writing by the Company is prohibited.

Title to and liability for the "Excluded Materials" shall always remain with the Customer. Title to the Customer's Waste Materials is transferred to the Company upon the Company's receipt or collection, unless otherwise specified in this Agreement or under applicable law. The rental price of the dumpster may be subject to change if the materials inside the dumpster do not match the materials originally quoted or rented for. The customer is responsible for all items placed into the dumpster during the rental period.

For instance, if a dumpster intended for wood waste only is rented, and the dumpster is returned with mixed (commingled) debris, the customer will be subject to the disposal price for mixed debris. All dumpsters are not to be used for concrete washouts or for the placement of wet concrete. Any wet concrete or slurry placed into the dumpster is subject to our damage charges.

CUSTOMER DUTIES/RESPONSIBILITIES: The debris box provided by the company always remains the property of the company. The company holds no responsibility for damage to the customer's pavement, concrete, driving surfaces, or any other surfaces resulting from the weight of the company's vehicles servicing the location as designated by the customer.

By signing this contract, the customer agrees to defend, hold harmless, and indemnify the company against all claims, lawsuits, demands, and liabilities arising from injury to persons or damage to property or the environment related to the use of the debris box or dumpster by the customer, or due to any breach of warranty by the customer.

It is the customer's responsibility to ensure that adequate roadways or driveways are provided for the desired delivery location. The customer assumes full responsibility for any damages caused to roads or driveways by the vehicle or container. Our trucks and containers are heavy equipment that may cause damage to driveways, streets, yards, or curbs along the delivery path or placement area. In such cases, GreenWaste cannot be held liable.

While the equipment is on rent, including during the rental period, the customer bears responsibility for theft, damage, fire, destruction, or injury associated with it. If we are unable to deliver due to factors such as blocked placement sites or the inability to reach a contact person, a dry run fee may be charged.

Our drivers will exercise discretion when driving across lawns, unstable terrain, sidewalks, driveways, or areas with overhead obstacles. If the customer or renting party is using the debris box on a property they do not own, they assume all responsibilities for damages as stated in this contract.

For situations involving homeowners' associations (HOA), apartment complexes, or any type of rental property, where the dumpster is not rented by a legal representative of the property, the renting party is responsible for obtaining permission for placement. If GreenWaste is contacted by a legal representative of said property, the renting party will be notified. If removal is required before the end of the rental agreement, no refund or discount will be issued.

The dumpster's weight or overfilling might result in marks or damage. To mitigate this, we advise customers to consider laying plywood over their driveways to provide protection against potential harm. While using plywood could assist in averting damage, it's important to note that this doesn't guarantee prevention. Please be aware that GreenWaste holds no responsibility for any damages or marks incurred on the driveway.

For quantities exceeding one yard of dirt, concrete, bricks, asphalt, or any combination thereof, in dumpsters other than the 10yd, a minimum hard-to-handle fee of \$150 will be imposed.

Customers are encouraged to be on-site at the time of delivery to ensure proper placement. If the customer is not present and cannot be reached by the driver, our drivers will use their best judgment based on instructions provided at the time of order placement.

If the customer requests the box to be moved for any reason, a minimum charge of \$99 will apply. Customers are prohibited from moving the dumpster to a different job site location. A new haul charge may be imposed for an address other than the one the dumpster was originally delivered to.

The customer warrants that the dumpster will only be filled level with its top and not overloaded. Mechanical compaction or smashing of materials in our dumpsters by companies like Crushr, Smash My Trash, or other mechanical equipment is not allowed. The customer is liable for any incurred damages.

Customers are responsible for any additional costs resulting from an overloaded condition, including fines incurred by law enforcement. Dumpsters exceeding 10 tons may be subject to additional hard-to-handle fees starting at \$150, in addition to any overage fees.

Customers are prohibited from overloading the debris box or dumpster or using it for incineration purposes. The customer is liable for any loss or damage to the dumpster, except for loss or damage resulting from the company's handling of the dumpster.

In case of any damages to the dumpster not disclosed to the driver at the time of delivery, customers will be charged a repair fee of \$95.00 per hour. If a dumpster or covered dumpster cannot be repaired, the customer will be held liable for the full market value of the dumpster and its accessories.

When encountering rainy conditions, it is recommended to employ a tarp to cover the dumpster. Please note that disposal facilities do not offer discounts based on water weight, and thus no such discounts will be granted.

GreenWaste of Sacramento is not responsible for damages that may occur to customer's property when providing service as directed by the customer, renting party, or their agents.

Unacceptable Materials

Loose yard waste exceeding a ½ cubic yard of grass clippings, leaves, weeds, pine needles (branches and brush are ok), food waste, Hazardous Materials including but not limited to asbestos, oil & chemicals, lacquer, paint thinner, and wood stain, anything liquid-based cannot be placed into our roll off containers. This includes household cleaners, contaminated soils and absorbents, pesticides, HAZMAT materials, anything flammable, wet paint, oil, gasoline, propane, mercury-based materials, or appliances with liquids associated with them (AC units, refrigerators are ok if placed closest to doors of the dumpster, additional charges do apply), oil filters, batteries, etc. These liquids can seep into the ground at the local landfill and contaminate our local water supply. No treated wood waste, fluorescent bulbs, no Lithium-Ion batteries, no batteries of any type, medical infectious waste is defined as any material used in medicine or anything that has met bodily fluids. This includes animal carcasses or body parts, Dialysis waste, hospital blood bags, human blood, or blood-soaked fabrics, unused or expired drugs and prescriptions, used needles and sharps.

A general list of allowable items includes boxes, mattresses, dried paint cans, toys, rags, clothing, tables, documents, fire damaged items, water damaged materials, cabinets, sinks, screens, wood lumber, pallets, fencing, plywood, and lumber used for cement forms. Metal affixed to the lumber such as nails or hinges are acceptable., trash, furniture, couches, tables, mattresses, box springs, chairs, dressers, bookcases, barstools, entertainment centers, hutches, China cabinets, and other furniture can be disposed and are accepted in our dumpsters. brush, tree limbs, small trees, bushes, branches, tree rounds, tree chips, brush, some leaves. Tree rounds and trees must be less than 4 ft and have a diameter of no more than 2 ft, anything over 2ft will be charged as oversized. Palm, cattails, bamboo, are okay.

Construction and Demolition Debris (C&D) Recycling reporting not included in \$199

We specialize in recycling construction and demolition debris (also known as C&D debris), most non-hazardous construction debris may be placed into our dumpsters including but not limited to siding, and all types of flooring, sheetrock, insulation, wood debris, lumber, fencing (no treated wood), glass windows, rebar, metal, pipes, sinks, counter tops, bathtubs, glass, plastics.
