Service Changes and Enhancements

Residents will continue to use existing carts and regular collection days will remain unchanged.
Please contact us at **(408) 938-4970** or **SantaCruzCS@GreenWaste.com** to make service level changes.

The following service changes/enhancements are reflected in the residential rates below:

- One free bulky item collection per year and two on-call curbside collections,
- One waste drop-off event and one landfill voucher for disposal of large items and limited household hazardous waste (e-waste, batteries, and bulbs) annually,
- Cleaner waste hauling vehicles on the routes, to reduce noise and meet new California Clean Air Standards, and
- Additional support for recycling and composting, as required under SB 1383 (the new state law for mandatory organics recycling).

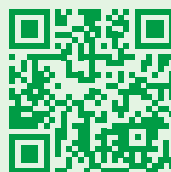
Standard & Low-Income Residential Rates



Standard monthly service rates include one recyclables cart (default size is 64-gallon) and up to three 96-gallon organics carts. Additional recyclables carts are available upon request, at no additional cost. Up to five additional organics carts are available upon request, for an additional monthly charge.

* "Hard to serve" refers to a service location whose regular collection of garbage, recyclables, and/or organics requires the use of a smaller truck due to difficult collection conditions such as weight restrictions on access roads/bridges and winding/narrow roads that a standard collection vehicle cannot navigate.

Low-Income Garbage Rates

1. Apply for PG&E California Alternate Rates for Energy (CARE) Program

Low-income garbage rates may be available for customers who are enrolled in the PG&E CARE Program.

To enroll in the PG&E CARE program:

2. Apply for Low Income Garbage Rate

Call GreenWaste at 408-938-4970 to apply for a reduced garbage rate if you can show proof of the PG&E CARE program and are the head of the household (not a dependent on any tax form), have no billing delinquencies, and have eligible service levels within the limits of the Low-Income Rate.
