## Prevent Battery Fires

Batteries and electronics with batteries do not belong in any of your carts or bins. They are considered household hazardous waste and can cause fires in collection vehicles and at the Material Recovery Facility where they are sorted.

Follow these steps to dispose batteries safely:

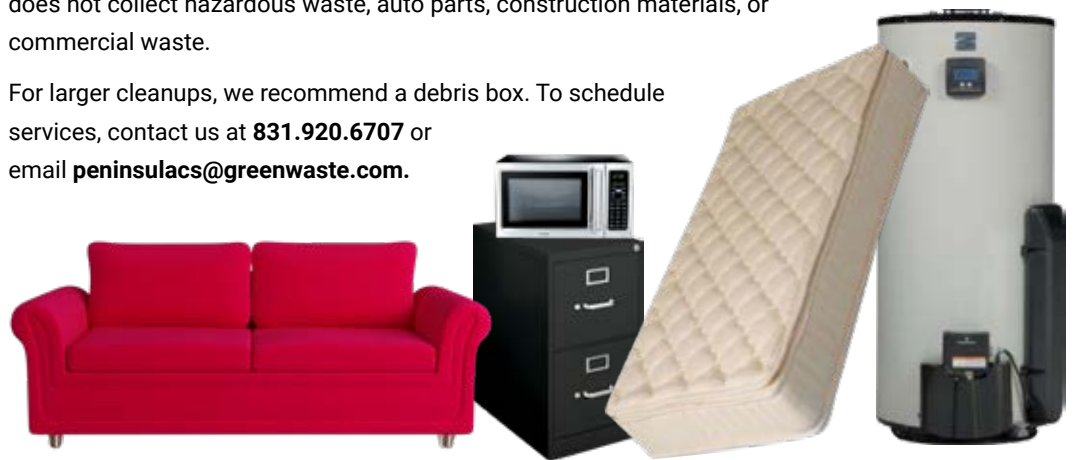
- 1) Collect your household batteries, including AA, AAA, C, D, 6-volt, 9-volt, camera batteries, nickel cadmium, and lithium ion.
- 2) Contact ReGen Monterey at **831.384.5313** or [regenmonterey.org](http://regenmonterey.org) for information or check drop-off location and hours online.
- 3) Drop off your batteries for safe disposal and recycling at 14207 Del Monte Blvd or participating hardware stores.



## Bulky Item Collection

For businesses with limited space, disposing bulky items such as mattresses, furniture, and appliances can be a challenge. If you don't have a truck to haul these away, let GreenWaste help! GreenWaste can pick up and dispose of bulky items for a fee per item. By using this curbside service, you'll keep your property clutter-free and safe for our drivers and your employees. ## Cardboard Breakdown

Remember to flatten your cardboard before placing it in your blue recycling container(s) to preserve space! As a reminder, cardboard must be unwaxed, clean, and dry to be recyclable. Lids of bins and carts must be completely closed on service day or additional service charges may be applied to your account. Keeping the lids closed reduces litter and ensures safe collection for our drivers. If your recyclables are often overflowing, request an Environmental Outreach Coordinator at **831.920.6707** to help rightsize your services. ## SB 1383 and Organics Reminder

As of 2022, California Senate Bill 1383 (SB 1383) requires all residents, properties, and businesses to remove organic materials such as food scraps and yard trimmings from their garbage stream and subscribe instead to organics collection service (or be approved for a waiver through the city). Your city is monitoring compliance and may issue violation notices or penalties for those who do not comply.

Already have organics and recycling containers available at your business? Consider these waste-reducing practices to benefit your business and potentially reduce your GreenWaste bill!

- 1) **Becoming a Certified Green Business:** Visit [greenbusinessca.org](http://greenbusinessca.org) to apply.
- 2) **Supporting edible food recovery:** Some businesses may be required to donate edible food under SB 1383, but everyone can help! Look out for food recovery organizations near you.
- 3) **Swapping out single-use plastic and foodware:** Opt for reusable or BPI-certified compostable ware.
