Short-Lived Climate Pollutants Law SB 1383 Now in Effect

Across the State, we are working toward a 75% reduction in food and yard waste sent to landfills and a 20% increase in edible food recovery. Organic materials decomposing in the landfill create methane gas, and in order to reduce organic materials in the landfill, all businesses are required to collect and place food scraps in their green organics container along with any yard trimmings. Shifting food scraps and yard waste from the landfill will help put carbon back into the soil to help prevent climate change.

In addition to diverting organic materials to composting programs, State law also requires edible food generators to send surplus edible food to food recovery organizations. To determine if your business is required to participate, visit calrecycle.ca.gov/organics/slcp/foodrecovery/donors/



CONSPICUOUS CONTAINERS AB 827



Businesses must provide organic/food scrap collection and recycle containers services for employees, tenants, contractors, and customers. To reduce contamination, businesses must periodically inspect the waste stream and must provide education to all the above-mentioned parties how to properly sort materials into the correct containers. Have a few grabbers and gloves for employees to correctly sort any waste that was put in the wrong can.

A container with mixed waste such as recyclables, food scraps, and trash may be turned away from the landfill due to contamination. The Zero Waste Team at the County of Santa Cruz Public Works can assist you in staff training and brief you on how to sort and reduce your materials. Request training at zerowaste@santacruzcounty.us
